\$47.3 MILLION RECEIVED FROM INSTITUTIONAL INVESTORS UNDER FIRST TRANCHE OF PLACEMENT

International iron ore company Sundance Resources Limited (ASX: SDL – "Sundance") is pleased to announce that subscription proceeds of A\$47,326,694 have been received in relation to the first tranche of placement shares issued pursuant to the A\$85 million private placement announced on 6 November 2009.

The Company has issued 315,511,294 shares at \$0.15 per share to international institutional investors in this first tranche of the placement. The balance of 1,295,127 shares are expected to be issued shortly taking the total amount received under the first tranche of the placement to \$47,520,963.

The second tranche of the placement will be completed upon shareholder approval being obtained at an Extraordinary General Meeting of shareholders to be held on 9 December 2009. This second tranche will comprise the issue of 249,860,246 shares at \$0.15 per share, raising an additional \$37,479,037.

The proceeds of the placements are to be used to:

- complete Definitive Feasibility Study of the Mbalam Project, including mine, process, transport and port infrastructure;
- undertake drilling to define further High Grade mineralisation with a view to achieving up to 10 years of DSO-quality production; and
- provide general working capital.

Renaissance Capital acted as Bookrunner for the placement with EAS Advisors Inc acting as Selling Agent.
